## **CCRIM SPONSORSHIP RULES & REGULATIONS**

The rules and regulations governing sponsorships in the Contra Costa Realtor in Motion (hereafter referred to as "CCRIM") are now part of the Sponsorship Agreement.

### **PAYMENT**

Payment is due upon submission of the completed Sponsorship Form. Applicants will not be entitled to sponsorship benefits until full payment is received.

### **ACCEPTANCE OF SPONSORSHIP**

Submit a completed Sponsorship Agreement before the event to be considered for sponsorship. CCRIM reserves the right to reject any application. Approval is contingent upon review by CCRIM, and no placement is guaranteed until approved. All sections of the Agreement must be completed for consideration.

### **CANCELLATION**

If a sponsor cancels, they must issue a cancellation request in writing and provide at least 60 days' notice. All cancellations and reinstatements are subject to the CCRIM board's approval.

### **USE OF SPONSORSHIP**

Sponsors cannot transfer, subcontract, or split their allotted sponsorship. Each sponsor can promote their business at events, including offering discounts, raffling prizes, or distributing promotional items. The CCRIM must approve all promotional activities before events to ensure compliance.

### **LOGO PLACEMENT**

CCRIM determines the placement of logos on marketing materials and social media posts, striving for appeal and clarity. If sponsorship is paid after materials have been distributed, efforts will be made to incorporate logos into subsequent distributions.

### **ASSIGNMENT OF SPACE LOCATION**

CCRIM cannot guarantee table or space availability at every event due to venue differences but will endeavor to provide as permitted. CCRIM may assign tables and spaces to sponsors.

### **INSTALLATION, REMOVAL AND RESTRICTION**

Sponsors are responsible for the delivery and removal of equipment, display materials, and promotional products to and from the venue. CCRIM is not liable for lost or stolen items. CCRIM reserves the right to ask to remove any exhibit part deemed inappropriate for the event or not in its best interest.

### **EQUIPMENT AND INTERNET ACCESS**

CCRIM does not guarantee internet or electrical power access. Sponsors should plan accordingly or check with the CCRIM committee for availability.

### NATURE OF RELATIONSHIP

CCRIM is not exclusive to any industry or company. Acceptance of the Sponsorship Agreement does not entitle sponsors to exclusive industry arrangements or constitute an endorsement of their services or products.
